

Sergio García Agreda Ballivian began his career in Informatic studies between 1993 and 1996 and complemented it with Business Administration from 1996 to 2003, developing a wide knowledge on companies' management, supported by tools in management information systems. He developed his training through postgraduate studies; in 2004 through 2005 he obtained a Master's degree in Business Management and Administration at Universidad Privada Boliviana (UPB) and an MBA at Universidad de Santiago de Chile (USACH), Chile, with a mention in strategic business management, which provided him with tools for companies' management. He holds a Ph.D. of Business Organization at Universidad Politécnica de Valencia, Spain – Universidad Privada Boliviana (UPB).

Currently he is the director of the **Internationalization Department at UPB**, a position he holds from 2016 to date, successfully developing: global development, business development and executive development centers, generating international conventions, international stay programs, business visits, and certification programs for internationally certified entrepreneurs. He is a Senior Consultant and Mentor in Business Development, where he worked in the formulation of Business Plans for the creation of a large group of companies, in addition to becoming advisor, with a total of 14 years of experience, for different organizations and business management programs, such as conducting consultancies for Cede - Mype - IDB for its program focused on the development of companies, as well as consultancies for the entrepreneurial development programs for CAF – Swisscontact Entrepreneurial Ideas, and, with UPB, has participated in management development programs with ICO, FEPADE, FTDA Valles - CASDER, Danish Foundation and the business development program for disabled people, Soboce Entrepreneurs. He also developed the Juvemprende Entrepreneurs Program for the World Bank, from 2010 to 2011 he was coordinator of the program to simplify construction procedures and permits for the IFC – BM in Santa Cruz, Bolivia. He was advisor to IT development companies, oil services company, hotel, eco resorts and companies within the field of construction and building materials, tourism, transport and marketing companies. financial institutions and investment funds. He also has international alliances and strategic partners in consulting and training in Asia, Europe, USA, Latin America and the Middle East.

In the academic area, undergraduate teacher at UPB of various general management modules from 2005 to 2017. He is currently teaching Business Management, Leadership, Digital Business Strategies, Global Trends and Global Business, for UPB, Universidad Politécnica de Valencia, Thunderbird, Missouri State University, ESAN Peru, ICDA Argentina and IESEG Paris. Having taught courses for senior management in all of the regions of the country and internationally, he is considered one of the most accepted teachers in the satisfaction assessments noted by students. He is the International Postgraduate Programs for Business Management and Business Creation Programs Director from 2008 to date.
