
JULIO SERGIO RAMIREZ



Dr. Ramírez, who was born in Colombia, holds a Ph.D. degree of Political Economy and Governance from Harvard University, and a Masters degree of Public Management also from Harvard. In addition, he holds a MBA degree with high distinction from INCAE and a Civil Engineer degree from the Universidad Javeriana in Bogotá, Colombia.

Until early 2001 Dr. Ramírez was the General Director of the Masters for Development Program (MpD) of the Universidad Católica Boliviana. In addition, he was the Director of the MpD-sponsored MBA Program in Santa Cruz. He is also the Academic Director of the MBA Program of the Universidad Católica Nuestra Señora de la Asunción, in Asunción, Paraguay, and Full Professor of Management Decision, Negotiation, Ethics and Leadership, and Business Strategy.

Between August 1994 and December 1997 he was Chief of Party and Senior Resident Advisor of the Human Resources for Development Project carried out by the Harvard Institute for International Development at the Universidad Católica Boliviana (UCB), a project sponsored by the United States Agency for International Development. Among other goals, this project aimed to developing three new masters programs at the UCB: Public Policy and Management, Financial Control and Audit, and Business Administration. Later on, this project was turned into the Masters for Development Program of the UCB.

For over 20 years (until August 1994) Dr. Ramírez was linked to the Faculty of INCAE. There he served as researcher, Professor of the Executive and Masters Programs, Director of the MBA Program, Director of the Private Sector Support Program, and Director of the Management for Development Program. At the time he left INCAE he was serving as Full Professor of Environmental and Political Analysis.

At INCAE's MBA Programs he taught the following courses: Political Analysis for Managers, Environmental Analysis, Compared Political and Economic Systems, Business Strategy, Development Policies, Project Evaluation, Public Management, New Business Management, Management Communication, Research Methods, and Management Decisions. Dr. Ramírez has taught a large number of seminaries to executives and board members of private and public

organizations on subjects such as organizational strategy, environmental and political analysis, negotiation strategies, structural change process management and economic reform policy.

Dr. Ramírez has consulted with different governments, NGOs, and international entities, as well as with public and private organizations in both Central and South America, on environmental and political analysis, political change processes, business and institutional strategy, and process evaluation and impact of training programs for top executives. Also, he has conducted top-management workshops for both public and private organizations.

Dr. Ramírez has also lectured in a large number of congresses and professional and business fora in different countries of Central and South America, on subjects such as global trends and their impact on the political and economic order; public-private sector negotiations; business strategy in times of crisis; leadership and organizational change, and the political process of economic reform.

Dr. Ramírez has researched the political role of private sector organizations, structural change management, the impact of modernization on the political stability of Central American countries, the regulation of intense political conflicts in transitional political systems, and the political management of economic adjustment processes.
